- 21.21 (c) All play yards for the dogs that are around the house that are bare dirt need to have stone put down to eliminate excess water and pooling of water. Play yards can not be allowed to be come muddy.
- 21.22 (c) All dogs need to segreated by sex and behavior issues. 18 Adult dogs running in a pen with each other reguardless of sex which also included pregnant dogs.
- 21.24 (b) Clean bedding not being used.
- 21.28 (a) Food buckets along with food in said buckets contaminated with dirty bedding.
- 21.28 (b) Water provided for all dogs was brown and contaminated with dirt and debris
- 21.28 (c) Food and water buckets were chewed and need to be replaced or the sharp edges need to be removed. Food and water buckets need to be kept clean.
- 21.28 (d) Bedding being used is not being kept clean.
- 21.29 (a) Excreta not being removed from the primary enclosure on a daily basis.
- 21.29 (b) Primary enclosures not being sanatized daily. Large accumulations of feces and dirt and debris in kennels and accumulations of old white dried feces in kennels.
- 21.29 (c) Kennel grounds and buildings not being kept clean. Minor amounts of wasps nests in kennel area. Rat feces in kennel enclosures along with minor amounts of spider webs and other cob webs.
- 21.41- (a), 21.41 (b), 21.42, 455.8, Unable to view records at inspection. Kennel owner called 911 and was admitted into the hospital. Numbers of dogs sold or transfered were not able to be viewed.
